The SFMO carries out its mission through four bureaus: Code Enforcement, Fire Investigations, Fire Service Support, and the Fire Training Academy.

- Received dual accreditation through Pro Board and IFSAC.
- Completed thermal linings in new burn building.
- Updated furniture in Academy lobby and classrooms.
- Upgraded academy with a new roof on admin and student staging, new AC/heating units on admin, and all AV equipment in the classrooms.
- Developed a master plan for replacing administration building, upgrading and adding new training sites to the facility, including ARFF pad, Hazmat Pad, and EVD course.
- Implemented new testing software to streamline the process and allow online testing in the future.
- Received AFG grant funding for equipment including 2 new trucks, 3 trailers, and equipment for the hazmat and VEX trailer.
- Purchased new ladders, hose, extrication tools, and PPE for instructors.
- Added new courses to include Aerial Ops, Live
   Fire Instructor and Live Fire Instructor In- Charge,
   as well as the National Traffic Incident
   Management course.
- Successfully increased our departmental outreach for non-certification training by travelling around the state to conduct entry level training on topics for local departments.





# **CODE ENFORCEMENT**



The Code Enforcement Bureau provides for the life safety of occupants in buildings, structures, and facilities, the prevention of fire and the reduction of property losses due to fires. The State Fire Marshal's Office has adopted the ICC International Fire Code 2021 edition to assure standardization of life safety concerns statewide.





## **CODE ENFORCEMENT**

In Fiscal Year 2024, the Code Enforcement Bureau worked across the state to ensure the safety of buildings, new and old. Inspectors worked across the state to inspect record numbers of building, review projects and plan, and educate those they serve on the standards that exist to keep New Mexicans safe.

# FIRE SUPPORT BUREAU




The Fire Support Bureau is responsible for the distribution of funds from the State Fire Fund and provides assistance to local fire departments in preparation of Insurance Service Office (ISO) surveys. The bureau also reviews fire apparatus specifications in accordance with National Fire Protection Association (NFPA) standards, performs site feasibility inspections for new fire stations and districts, and conducts certification inspections of new stations and fire districts for funding purposes. The services provided by the bureau promote increased fire protection in all communities which result in reduced loss of life and property from fire incidents and lower insurance rates (where applicable) for the citizens of New Mexico.





## FIRE SUPPORT BUREAU

- Had 27 fire departments improve their ISO rating Statewide.
- Fire Support increase the number of inspectors to provide more coverage to the fire service.
- One inspector is assigned to the 8, 9, and 10 departments to identify the needs and guide them to improve their ISO ratings.
- Increased our fire prevention outreach program to the schools teaching the kids the importance of fire safety.
- Increased our fire prevention to state employees with fire extinguisher training.
- Added a new fire prevention trailer to move fire prevention materials.



- Increased Fire Fund distribution to departments by \$1.5M, totaling \$77,316,129 in FY 24.
- Brought fire departments in the state to 95% compliance with reporting to NFIRS monthly.
- Completed 540 fire department inspections.
- Audited 100% of the fire departments in New Mexico.
- Distributed 100% of the Fire Fund grants to departments on time.





## FIRE INVESTIGATION BUREAU

The Fire Investigations Bureau is responsible for determining the origin, cause, and circumstances related to a fire incident. State fire investigators respond to requests for assistance from local fire departments and law enforcement agencies and assist the Office of the Medical Examiner (OMI) in fatal fire incidents.

September 2023, Fire Investigations staff responded to a fire located at the Wal-Mart in Clovis, NM. The five-day origin and cause investigation was a team effort involving SFMO, ATF, Clovis PD, Curry County Sheriff's Office, and Curry Co District Attorney Office. The investigation determined the fire was intentionally set by a homeless individual who entered the store after hours and caused approximately \$42M in damage. There were no fatalities or injuries as a result of the incident. The suspect was later apprehended in Texas and has been indicted on federal arson charges.

SFMO investigators along with ATF certified fire investigators secured indictments and a conviction in US Federal Court in California in March 2024 regarding a serial arsonist who traveled the southwestern US setting fires to Swift Transportation long-haul trucks from 2020-2022. The fires occurred at various truck stops located on I-10 and I-40 stretching from Alabama to California. A total of 24 truck fires occurred with 9 occurring in New Mexico. There were no fatalities or injuries as a result of the fires. The federal case originated from investigative work done by NMSFMO staff.

In February 2024, SFMO investigators and Alamogordo FD/law enforcement secured a conviction for arson and murder regarding a March 2021 homicide incident in Alamogordo, NM. The defendant killed his roommate and set fire to their RV to conceal the crime.



# STATE FIRE MARSHAL'S OVERALL FISCAL YEAR 2024 ACCOMPLISHMENTS

- Supported the addition of State Fire Plan Retirement for uniformed state fire Personnel. This includes both the Fire Marshals office and State Forestry.
- Secured \$25M for firefighter recruitment within the state, A big thank you to all that attended these meetings and supported this.
- Secured \$2M for the Firefighter Training Academy for upgrades to the facility.
- Secured \$3.1M for planning and development of a satellite training facility in Santa Fe, to include a firefighter memorial.
- Adjusted the inspector pay band to pay range 70 with salary.
- Added new positions to make the department more efficient, including an executive admin and a human resource position.
